## Why the Attack on Police — From the Left, and Right?

Over the years, I have documented the conspiratorial plot to set up a global government, the latest being in the 2014 January, February and March issues of the *Liberty Tree* newsletter. But until we have accomplished rooting out the intellectual distortion of the Constitution we are faced with today, and it's purpose, the story must continue to be told.

Last month's Part I covered the attack on property rights, (*Pursuit of Happiness*), and the misdirection of police powers in violation of the *Oath of Office*. I also discussed the deviation of police powers from their original intent within the Constitution, through the establishment and expansions of unconstitutional police agencies.

In Part II, we are going to discuss the deep-rooted reasons and motivations behind such deviation, and the contemporary reaction to resist it. It is

this writer's hope and prayer that the information contained herein, will be first consumed and ruminated upon, and then widely disseminated. For if this conspiracy involving police powers is not reversed, Americans will soon be suffering under a total police state, created with their own unwitting cooperation.

As was documented in the above issues of the *Liberty Tree*, two important events began within three years of each other: in 1773, Adam Weishaupt's conspiracy to establish a global government; and in 1776, the evolving revolution that established – for the first time by man – a government based on nothing more than securing the *Unalienable Rights* given to man by the Creator. Studying the evolution of these events gives the appearance that they had been scripted right out of the Bible's *Book of Revelation*.

The global conspirators were, and still are, many

of the world's wealthiest financiers, who have the financial and political connections to be able to place their agents in positions of influence in government and the marketplace. On the other side, the agitators for Liberty from the long-established feudal system of monarchy were more individualistic and anxious to limit the ill effects of government on its citizens.

The conditions that brought on this confrontation actually grew out of the religious reformation of the European Christian community. This in turn started because of a German Roman Catholic scholar and priest's disillusionment of the edicts of Pope Leo X, who sold indulgences in Germany to finance the renovation of St. Peter's Basilica in Rome. Thus, on October 31, 1517, Martin Luther nailed his *95 Theses* – which contained the revolutionary opinions that would begin the *Protestant Reformation* – on the door of the Castle Church in Wittenberg, Germany.

This act of rebellion instigated study of the Holy Scriptures, which was forbidden by the Vatican. The different theories of the New Testament Church resulting from such studies ultimately evolved into several different Protestant Religions. These upstart new Christian Churches came under persecution by the political powers of the day, still under the influence of the Pope – an influence started by the Roman Emperor Constantine that remained unopposed for 1,217 years. Martin Luther himself came under a death warrant issued by the Holy Roman Emperor Charles V of Germany, and escaped death through the protection of Prince Frederick of Germany.

As the Reformation gained popularity, influential converts in the Monarchal Courts of Europe were able to obtain charters to establish religious colonies in the newly discovered American continent, avoiding the persecution instigated by the Vatican, and the Episcopal Church of England. The Monarchs of Spain, France, England and the Dutch Republic issued these Charters and used them to extend their political control in the New World: Spain, in what is now Mexico, Florida and the southern U.S, from Texas to California; France, from eastern Canada across the upper mid-west U.S., down to the Gulf coast; England, in Canada and the east coast of the U.S.; and Dutch Republic, in the Hudson Bay country, establishing the city of New Amsterdam on Manhattan Island. In 1665, England took over Man-

hattan Island, renaming it New York. England ultimately prevailed in the struggle for control of the New World to become the dominant influence, and in little over a century, its colonies evolved into what is now known as the United States of America, and the Dominion of Canada.

In this same period, English philosopher John Locke (1632 - 1704), published a treatise on religious tolerance claiming that all people were equal and independent, and that everyone had a natural right to defend his *Life, health, Liberty, or Possessions*. This new philosophy took hold, and challenged the long-held theory of the *Divine Right of Kings*, especially in the English colonies in America.

Samuel Adams, known as the *Father of the American Revolution*, became captivated by Locke's theories while attending Harvard College (1736 - 1740). Adams continued his studies and earned a master's degree in 1743. In his thesis, he argued that it was "lawful to resist the Supreme Magistrate, if the Commonwealth cannot otherwise be preserved," giving evidence of Locke's political influence. For the next 30 years, he took every opportunity to agitate for the colonies to separate from the English Monarchy, including organizing the Sons of Liberty, and in 1773, leading the Boston Tea Party.

During this same period, Sam's cousin John Adams practiced law in Boston, and though he resented the high-handed actions of King George, was not as enthused as Sam over Locke's political theory. This sort of mixed political alliance seemed to prevail in the other colonies as well, and continued even after the signing of the Declaration of Independence. This, in essence, is the root of the problems Americans are facing today.

After the separation from England, and with the Confederacy government failing, the States sent delegates to a Constitutional convention held in Philadelphia, Pennsylvania in 1787. Virginia Delegate James Madison kept a day-to-day account of the convention proceedings in a journal. A study of his journal reveals that Locke's religious and political theories, also expressed by Thomas Jefferson in the Declaration of Independence, were the controlling factors in the drafting of the United States Constitution. And upon its ratification by the States in convention, a government was instituted to secure

the Unalienable Rights given to man by his Creator, breaking centuries of control under the theory of the *Divine Right of Kings*.

The Articles of Confederation only linked the States by a national Congress, which had no actual power over the States. The Constitution created a federal government with limited control within the States, as enumerated in Article 1, section 8, but no control over the lawful intercourse among the citizens therein.

There were three prevailing political thoughts at the time:

- The *Federalists*, who favored a federal government with limited powers;
- The *Anti-Federalists*, who feared any form of federal control; and,
- Those who called themselves "*Federalists*," but who did not believe in limited powers, and secretly worked to advance a system with a strong federal government.

Thomas Jefferson and James Madison, ardent believers in the government established by the Constitution, founded the *Democratic-Republican Party* in 1792. In that same year, Alexander Hamilton, a monarchist and secret globalist agent, founded the *Federalist Party*, which drew its members from the ranks of the non-believing aristocrats.

Hamilton's choice of the name "*Federalist*" for his political party was devious, in that it used the popularity of the new Constitutional government, but not with the same intention for which that government was formed. He used his influence as the first Secretary of the Treasury to establish an unconstitutional National Bank, and involved the global government co-conspirator, Nathan Rothschild, as that Bank's European financial agent. Because of the public's lack of awareness of the misuse of the *Federalist Party*'s name, he was able to saturate all three branches of the federal government with individuals who believed in an aristocracy; and we are still suffering today from the effects of the precedents set by their accomplishments.

The struggle between those believing in Locke's theories and those holding onto the aristocratic viewpoint continued, but over time the influence of the former slowly waned. This was due to the sig-

nificant influence exercised by the globalist conspirators, even while they were able to remain anonymous and out of public view.

This struggle reached its climax with the Lincoln administration, which in complete disregard of the Constitution, declared war and aggressively attacked the foreign country created by the States which had lawfully seceded from the United States of America. These cotton-producing States seceded over the irresolvable issue of Congress' imposition of heavy tariffs, enacted into law by the dominating number of representatives from the industrial northern States.

With the Confederate States of America's loss in the War of Northern Aggression, the federalists, with their global conspiracy allies, took advantage of the reconstruction period following the war to instill a dominant federal government that controlled every aspect of American life. The Constitutional mandate of a limited federal government securing citizens' unalienable Rights and observance of each State's sovereignty and jurisdiction, became a thing of the past. Every administration since Lincoln has built on this foundation of sedition, until now the Constitution is of no effect – resulting in run-away debt, unlawful and abusive taxation and tyrannical edicts.

With Lincoln securing the beachhead, and Karl Marx planting the seeds of socialism, the agents of the global government conspirators started infiltrating every phase of American public life: government; education; and the news and entertainment media. They took their direction from George Bernard Shaw's Fabian Socialist Society. The methodology was to advance extremely slowly over generations, so that there would be no reaction, and the changes would be accepted by unknowing Americans as natural occurrences.

The successful progress of the globalists can be measured by comparing the 10 planks in Karl Marx's Communist Manifesto with the operational practice of the federal government today. Well, the point is that the Fabian Socialist Society's plan is working, and right on track. The only real obstacle standing in the way of the globalists establishing their world government is the U.S. Constitution — the simple fact that it still exists. The globalists have not yet reached the point where they can overthrow it without any reaction. To the contrary, the use of the Internet — bypassing the establishment news media's blackout — to reveal the unlawful taxing of American citizens, out of control debt (owed mainly to those same globalists), and the rampant corruption in government, has now gotten citizens and even State legislatures starting to cry out for, and actually *applying* Federal and State Constitutional authorities in reaction to these revelations.

Hollywood's depiction of Sheriffs as being corrupt and misusing their power has not been successful, and the renaissance of the political power of that Office is evolving into a successful national movement enlisting Sheriffs to uphold their Oaths of Office, and refuse to enforce unconstitutional laws, both state and federal. And so, probably the most important part of the globalists' plan is being brought to naught. They would like to eradicate sheriffs — the only Constitutional law enforcement, answerable only to the citizens and their oaths — and replace them with local police forces, and ultimately to incorporate the local police into a national police force.

Throughout my fifty years as an organizer of political action organizations, I have experienced, even as early as 1966, unlawful interference by government agents, both state and federal. Some of them privately admitted that it was wrong, but that they were just doing their job as ordered. An attorney in the Department of Justice even admitted to Tommy Cryer and Larry Becraft that the DOJ had infiltrated the Patriot movement with agents provocateur to plant disinforma-

tion and to disrupt wherever possible.

Wherefore, I am very suspect of this obviously concerted effort to attack local police by the Left, immediately organizing demonstrations before there is even any credible evidence of wrong doing on the part of the police officer. I am also extremely suspicious of video clips posted on YouTube that do not show all of what has happened; just the part that could possibly be interpreted as wrong doing by police. It exceedingly smacks of the work of an agent provocateur, no different than the false flag events intended to justify the existence and expansion of a national police force.

Just think about it: there are just shy of 800,000 constitutionally sworn law enforcement officers in the 50 states, and the FBI reports that there are about 400 killings of thugs by local sheriffs and police per year. ABC News on July 14th reported that the Justice Department receives 12,000 complaints every year of law enforcement abuse, but fewer than 50 result in convictions. Yet the commies, the "progressive" politicians, the left-wing media, and their Patriot dupes are screaming "out of control police brutality."
