**Violating life, liberty and property
by police power!!**

On 9/11/2001, the world was “treated” to an alleged terrorist event that plunged America into a police state. The PATRIOT ACT and the REAL ID Act, direct attacks on Americans liberties, were just two of the desired outcomes achieved by the globalist elites via 9/11.

ment. Ivins was hounded until he committed suicide. To this day, no Muslims or terrorists have ever been identified as the mailers of the anthrax letters.

This is not to say that the anthrax letter episode did not serve an important purpose for the real perpetrators of the 9/11 event. The full purpose of those letters is now coming to fruition, in what could be termed phase two of the transformation of America — and the world — into a full police state.

Drafting despotism

In 1999, the federal Centers for Disease Control and Prevention (CDC) funded Larry Gostin, now a professor and co-director of the Center for Law and the Public’s Health at Georgetown and Johns Hopkins Universities, to write a draft Model State Emergency Health Powers Act (MSEHPA).² If this is true, then Gostin’s draft model legislation was conveniently on hand when the 9/11 and 9/18 events transpired.³ Immediately following 9/11, the CDC had Gostin revise his draft, and as of October 23, 2001, he had a draft ready for legislators to introduce into each State of the Union. (Gostin himself says that he wrote the “Model Emergency Health Powers Act for the White House after the World Trade Center and anthrax attacks in 2001.”)⁴ Gostin is a glob-

alist skill, for decades he has advocated for “Global Health Governance” funded by the IMF and World Bank.

By the end of 2011, 40 States had adopted some version of the MSEHPA. It appears, from the executive orders recently published by the governors of each State in response to the current ‘pandemic’ scare, that various provisions of the MSEHPA have been adopted by the remaining States since then.

Once the emergency health powers were in place, it was time to cue the coronavirus scare, a.k.a. the COVID-19 “pandemic.” Because of the 24/7 media and health commissar *hype* surrounding this alleged disease, *circus* is a better term. Similar virus scares have been dry runs for the current circus, the first being the SARS scare in 2003, which, in the end, allegedly sickened only 8000 people and killed 800. Of course, preliminary exercises like SARS were necessary for globalists, working through the WHO and the CDC, to continue to promote the ‘need’ for emergency health powers. Outfits like Gostin’s Center for Law and the Public Health, and the Johns Hopkins Center for Health Security, are funded to “assess” America’s emergency ‘preparedness’ with respect to emerging diseases. Naturally, until all the emergency powers were passed by the States, America was not yet “prepared” for the next emergent disease crisis. It is clear that by 2019, however, all the police power pieces were in place. It was time to claim the necessity of “public health” overrides your constitutional rights. Cue the coronavirus circus!

As everyone in America is now aware, most governors ordered public schools and other public agencies closed. Since these are government institutions, it is arguable that governors have such power. But the governors have not stopped there. They have ordered private businesses to close, have ordered the people not to gather in groups larger than a given size (most often 10). They have ordered churches and private nonprofits to close their doors. Even more, they have ordered people not to leave their homes unless it is for “essential” business. Who decides what is essential?

As of this writing, only four States appear not to have adopted some version of a stay-at-home order. But they too have ordered businesses closed, restricted “gatherings,” and left many people unemployed and unable to meet the economic necessities of life.

As the National Vaccine Information Center warned in 2003, the legislatures of the States have passed laws which allow State governments in the case of “emergency,” to, among other things:

- take control of all roads leading into and out of cities and states;
- seize homes, cars, telephones, computers, food,

fuel, clothing, firearms and alcoholic beverages for their own use (and not be held liable if these actions result in the destruction of personal property);

- arrest, imprison and forcibly examine, vaccinate and medicate citizens without consent (and not be held liable if these actions result in your death or injury).

Arkansas provides one example. The governor’s EO 20-13 states that by the authority of Ark. Code Ann. § 12-75-114(e)(7), “ingress and egress to and from [the entire declared disaster area of the State of Arkansas], the movement of persons within, and the occupancy of premises therein, may be controlled” by government. The Arkansas governor declared the whole state a *disaster area* based on the alleged COVID-19 threat.

Thus, the planning and drafting of the laws used for governmental takeover of medical establishments, businesses, and even travel was accomplished well before this present “crisis.” We are now experiencing the intended and despotic results of the model legislation drafted by the CDC, through would-be technocrat Gostin.

A Crisis or a Circus?

Save-A-Patriot Fellowship, and Liberty Works Radio Network, have consistently warned about the threat of the global elite to our God-given rights, and our economic freedom. We have continually exposed the enlarging totalitarian state under which Americans are suffering. In recent years, we have seen the exponential increase of government surveillance of everything via digital means, fusion centers, the NSA, and now, the threat of 5G and the “internet of things.”

This “coronavirus” (CV) crisis reveals the desire of the medical-industrial globalists to control each individual by monitoring their “health.” With respect to America, recall that Hillary Clinton’s task force failed to nationalize medicine and put everyone in the country in a “healthcare” database; Obamacare has similarly not gone far enough. In addition, opposition to vaccination is growing in recent years, and must be shut down if the profits realized by the pharmaceutical companies is to be not only maintained, but increased.

There are many signs that CV is a planned-demic rather than a pandemic, but there is room here only for a few points. A prime example is “Event 201,” a “tabletop” pandemic simulation exercise hosted by the Johns Hopkins Center for Health Security (JHCHS), which was conducted October 18, 2019.⁵ The virus that was posited in this exercise? Coronavirus. A “heavyweight” group of policymakers, business leaders, and health officials participated and

“discussed,” in apparently scripted fashion, how a coronavirus pandemic would/should be “addressed” by governments. A video of this simulation and “discussion” was uploaded to youtube on November 4, 2019. And then, it seemed to come true!! In just one month, there was an “outbreak” of coronavirus in China!!

The funders of Event 201 are an indicator that the CV crisis is for the benefit of the globalists. They include the World Health Organization of the UN (WHO), the Rockefeller Foundation, the Bill and Melinda Gates Foundation, the CDC, the FDA, the Department of Defense, Homeland Security (NBACC), the Taiwanese Ministry of Health and Welfare. In other words, the U.S. Government and globalists.

Ron Paul, former congressman and an M.D., has referred to the ‘pandemic’ as a hoax.⁶ He called out the chief fearmonger, Anthony Fauci of the NIH, on testifying to Congress that the CV death rate is ten times that of the seasonal flu, a claim without scientific basis. At the time Fauci stated this, CV was claimed to have killed around 5,000 worldwide. Paul pointed out that tuberculosis killed nearly 1.6 million worldwide in 2017 — yet no one calls tuberculosis a pandemic! Health official fearmongering over something that is no more a threat than a common cold or flu⁸ is evidence of the *planning* of this circus. Rahm Emanuel said governments should never let a serious crisis go to waste. How much more efficient and effective is it to control the narrative by *manufacturing* a “serious crisis” out of something that poses no true threat to public health?

On March 20, 2020, Secretary of State Mike Pompeo — formerly the CIA director — stated, in a CV task force press briefing: “[Getting proper CV data from China] matters going forward. We’re in a live exercise here. To get this right.” Just following the words “live exercise,” Trump, looking sideways at Pompeo and speaking in a low tone, said, “You should have let us know.”⁷ While this doesn’t *prove* that the CV hysteria is a planned exercise, it is just one more indicator that the globalists have planned this exercise in despotism.

As anyone who watches television or is on the internet can attest, the CV “crisis” is the major entertainment at this time. It has turned into a circus of fear, promoting trust in government diktats and distrust of your neighbors.

Planned goals of phase two

The 9/11 event did not accomplish the full police state desired by the globalists in America. Alleged terrorism, as a threat from foreign actors, was used to overcome individual liberty on a federal level, but was

not as successful on the State level. Moreover, it was not successful in fully controlling the masses. For control purposes, people must be divided, not just into identity groups (black, white, asian, women, transgender, etc.), but into individuals who are *suspicious of every other individual* they encounter. Thus, while ‘terrorism’ as a supposed threat furthered the “see something, say something” snitch society, it did not go far enough to break down the bonds between ordinary people. ‘Climate change’ as a supposed threat does not isolate people and break neighborly bonds, either. But the threat of an invisible ‘disease,’ a threat to life potentially carried to you by *everyone* you meet? Without a doubt, a ‘pandemic’ threat is powerful enough to divide each individual from every other individual, especially when rights to assemble are denied.

Already, State agencies and officials are asking people to snitch on any gatherings greater than 10 people. But a society of snitches, so necessary for complete control (just ask East Germany), is only one of the goals sought from this circus. There are many others, including: a cover for the economic panic that was already underway, solidifying more communism through federal reserve bank lending (*i.e.*, the stimulus bills), a massive move to digital platforms for every human activity, and mandatory vaccination and digital identification for all. There is not space enough here to describe all of these; hopefully, we will have time to address these goals in detail in future *Liberty Tree* issues.

Police powers to despotism

It has long been held by courts that States have “police powers” to protect the general safety, health, and morals of their populations. Of course, the limitations of said police powers are fairly vague, and so have been used to justify every deprivation of liberty, from zoning to fire and building codes to licensing restaurants and requiring public schooling. The “public health” departments of each State are similarly so justified, and the emergency health powers acts are also claimed to be justified by police power.

It is said that police power must be used to actually promote the interests of the public as a whole. But now police power is an excuse to close private businesses and put people in lockdown. For individuals, this is depriving them of their individual rights to travel, to work, to assemble, and to worship.

The “doctrine of necessity” of restoring order is used by governments to justify illegal actions. Such a doctrine must not be allowed to justify unconstitutional actions! We must resist tyranny. As Art. 44 of Maryland’s Declaration of Rights eloquently states:

That the provisions of the Constitution of the United States, and of this State, apply, as well in time of war, as in time of peace; and any departure therefrom, or violation thereof, ***under the plea of necessity, or any other plea, is subversive of good Government, and tends to anarchy and despotism.***

Christian duty in the face of the present tyranny

The mayor of Louisville, Kentucky, Democrat Greg Fischer, has, by usurpation, declared that churches may not meet on Easter for services — even drive-in services, where cars park next to each other and hear the preacher over a car radio! Absurdly, the mayor stated that this would “create a tinder box for the [corona]virus. It creates way too many opportunities for people to contract the disease.”¹

“Our job is to deny the virus,” the mayor told television station WDRB. “If we don’t do that, more lives will be lost. I know it’s tough...I just can’t allow [church services] to happen.” The *Courier-Journal* reported that the mayor wants people who “belong to a church that is defying Fischer’s request to contact their minister or the city’s 311 line.” In other words, Christians should snitch on other Christians.

While denying people the right to assemble and to exercise their religion in by meeting together ‘saves lives,’ the abortion clinics are still open and killing lives. The magnitude of this hypocrisy ought to take your breath away,

‘Pastor’ Steven Webb of the Dixie Valley Church of God provided approval for the mayor’s tyranny: “Scripture tells us that God tells us that we should obey the authority that he has placed over us ... And so for us it is no question that if the governor and the major has asked for us to do that then we should obey that.” One cannot imagine such a man would have called himself Christian for long in ancient Rome, where Christians were persecuted so severely that they met in secret.

The modern Romans 13 heresy — that Christians should obey government because government is “in authority” — ignores the true teaching of Romans 13. God alone is sovereign, and governments are in place only to punish evildoers. Governors, mayors, and other public officials want instead to punish Christians who practice their constitutionally guaranteed, God-given rights to assemble and worship God. They emulate the evil Pharaoh who refused to obey God’s command to “Let my people go, so that they may worship me.” (Exodus 8:1, NIV).

A Christian who unquestioningly believes in so-called medical science can fall into error concerning their faith. Those who heed the “science” of men — in this case, alleged public health science — above the words of Scripture will fall away from the true faith, just as “Pastor” Weber has done. The apostle Paul stated: “... keep that which is committed to thy trust, avoiding profane and vain babblings, and oppositions of **science falsely so called**: Which some professing have erred concerning the faith.” (I Timothy 6: 20-21, KJV).

For Christians, the Bible is the authority on how to handle everything in life, including illness and death. What then are the commands of Scripture? Firstly, Scripture commands that Christians not forsake gathering together:

Let us hold fast the profession of our faith without wavering; (for he is faithful that promised;) And let us consider one another to provoke unto love and to good works: **Not forsaking the assembling of**

ourselves together, as the manner of some is; but exhorting one another: and so much the more, as ye see the day [of judgment] approaching. (Hebrews 10:23-25, KJV).

Secondly, Scripture instructs Christians to handle sickness exactly *opposite* the global health magicians’ way. Rather than separating themselves from even healthy persons to avoid sickness, the followers of Christ are told to visit believers who are sick:

Is any sick among you? let him **call for the elders of the church; and let them pray over him, anointing him with oil in the name of the**

Lord: And the prayer of faith shall save the sick, and the Lord shall raise him up; and if he have committed sins, they shall be

forgiven him. (James 5:14-15, KJV).

Scripture records that the Lord Jesus and the Apostles laid hands on people who were sick, and they recovered. In Mark 28:17-18 (KJV), Jesus said of those who believe on him: “[i]n my name ...they shall lay hands on the sick, and they shall recover.”

What a privilege and opportunity Christians now have to show the difference between the lying devils of this world and the peace and faith which comes from reliance upon the Creator. Jesus spoke about the reward to be given to those who follow His commands in Matthew 25:31-40 (KJV, *edited*):

When the Son of man shall come ... then shall he sit upon the throne of his glory: And before him shall be gathered all nations: and he shall separate them one from another, as a shepherd divideth his sheep from the goats:

And he shall set the sheep on his right hand, but the goats on the left.

Then shall the King say unto them on his right hand, Come, ye blessed of my Father, inherit the kingdom prepared for you from the foundation of the world:

For I was an hungred, and ye gave me meat: I was thirsty, and ye gave me drink: I was a stranger, and ye took me in: Naked, and ye clothed me: **I was sick, and ye visited me**: I was in prison, and ye came unto me.

Then shall the righteous answer him, saying, Lord, ... **when saw we thee sick**, or in prison, and came unto thee?

And the King shall answer and say unto them, Verily I say unto you, Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me.

If you are a Christian, the choice is before you: obey the charlatans who want to establish a world government via such things as the corona circus, or obey the commands of Christ.
