

# BELIEVING LIARS

Hook shooting should not be trusted. He assured the public that only the information coming from him (“this microphone”) was the real deal. In a December 16, 2012 press conference, he even warned the public against trying to contact victims:

Truth is often an elusive thing. The more simple truths — *e.g.*, fire will burn you — are those that can be personally verified. However, the more expansive a truth becomes (the *whole* truth), the harder it gets to really know it for certain. Once the methods of verification get beyond our individual ability to perform them, or the information which would verify them gets beyond our individual ability to obtain it, we are left with the necessity of developing resources whom we can trust to obtain the information and perform the verifications for us.

This was one of the traditional roles of the media. It was a conduit for the information about what was happening in our communities, states, countries and world. The different media outlets developed their own trusted ‘sources’ of information — that is, ones whose prior information proved to be accurate over the years — and passed the results on to us. In turn, these media outlets became our own ‘trusted sources’ of news and information about the world around us. But still, we were rarely in a position to be able to verify it for ourselves. Yet, as long as they were able to maintain a façade of honesty, and until we *did* have personal knowledge of what was being reported (and thus could see how it differed from the reality we saw), most of us were lulled into believing that we were being told the truth.

## WHO ARE YOU GOING TO BELIEVE, ME OR YOUR LYING EYES?

Today that situation has changed quite a bit. Main stream media (MSM) now hardly seems to care whether the ‘news’ they report is even accurate. More and more, their sources are nothing more than government spokespeople, spinning whatever tales further the government’s agenda at that particular time. They no longer seem to have any interest in investigative reporting, whereby they might ferret out corruption in government or public affairs. In fact, I’d say that their lack of real exposure of such corruption, or of the inconsistencies in the information they’re being fed by their government sources, would lead one to believe that the MSM is actively colluding with the government to keep the public in the dark about current events.

It was rather funny to see the Connecticut State Police spokesman Lt. Paul Vance claiming on national TV that information that was showing up on “social media” outlets (like Facebook and Twitter) about the Sandy

“The last thing is I’d like to re-state that we stated this morning about anyone that harasses, threatens, or intimidates, or interferes with the investigation, utilizing any social media of any type relative to this horrific crime will be fully investigated and fully prosecuted to the extent of the law. We’re talking about harassment includes in-person contact but also contact on the Internet, social media, telephone, and any other means of communication.”<sup>1</sup>

Now, I’m not suggesting that it’s proper to harass the victims of tragedies, but certainly attempting to contact them through normal modes of communication doesn’t constitute harassment, unless it continues after such contact is declined by the victim. But, just as certainly, restricting the access to first-hand accounts of events is a useful tool of liars in order to maintain their false constructions.

This is especially true in the case of video footage of tragic events, like the Pentagon attack on September 11, 2001. After confiscating the video footage from all cameras in the area which could capture the images of Flight 77 hitting the Pentagon, one short video was released some six months later. The same kind of confiscation happened at the Murray Federal Building in Oklahoma City in 1995. The point is that everywhere you look, you see surveillance cameras. You can hardly walk out of your house anymore without appearing on some. Yet at all the major tragic events, it seems the ones which would most clearly show what happened, or *didn’t* happen, as the case may be, never materialize.

Another interesting development over the years has been the simultaneous training exercises that seem so often to exactly coincide with the major tragedies. I wrote about this back in September 2011 with respect to the WTC and Pentagon attacks.<sup>2</sup> As I mentioned in that

article, such coincidences can be no accident, and are evidence of some form of collusion or at least foreknowledge. But the absolute advantage to having prepositioned agents in the immediate area of a catastrophe is huge when it comes to controlling evidence. And control of the evidence — both inculpatory and exculpatory — being so important in every case, how convenient

it is when government agents can swoop in and snatch it right up, slapping gag orders on witnesses as they go.<sup>3</sup> In other words, setting themselves up as the sole source of the truth. Now, if the government could be trusted with the truth, and with relaying it to the public intact, there wouldn't be so much of a problem. But what happens when it can't be trusted?

**W**e know the government lies. They lie about major events that involve us in wars: Pearl Harbor (FDR's foreknowledge of the attack, according to Secretary of War Henry Stimson's diary); the Gulf of Tonkin Incident, which escalated the Viet Nam war;<sup>4</sup> the claimed weapons of mass destruction that were used to justify the war in Iraq. They lied about Israel's attack on the USS Liberty in 1967 (with LBJ's knowledge, according to the Liberty's Lieutenant Commander David Lewis' account of his meeting with 6th Fleet Rear Admiral Lawrence Geis).<sup>5</sup> They were prepared to lie about staged attacks to be blamed on Cuba, in order to justify going to war against them, but JFK wouldn't go along with the plan.<sup>6</sup>

The government lies about what they're doing, what they're not doing, and when they get caught in one of their lies, they lie to cover it up, and then lie about the coverup, too! The bottom line is that they lie about just about everything, sometimes even when it seems like the truth would serve them better. So, when it comes to *trusted* sources of truth, the government should be about the last source you should consider. In fact, the odds would probably favor you finding the truth by believing the exact *opposite* of whatever the government tells you.

This brings us back to the MSM, and their apparent penchant for using government spokespeople as their

main source for the information that they then feed to the public. How can a thinking person believe what MSM tells them, knowing that it is coming from such completely untrustworthy sources? And of course, this is where the alternative media outlets come into the picture. As more and more people begin to see through the incredible and implausible scenarios being painted of current events by the government and their MSM skills,

alternative media starts looking like a better and better option for finding out the truth.

**A**nd of course, that's where Liberty Works Radio Network comes into play. We want to be one of those sources that people can trust to *bring them the truth*. But, even if we may on occasion get something wrong, we at least want to be a source that people can trust to *not deliberately lie to them!* But our chance to be part of the change we want to see in this country — the return to limited government and individual liberty — is at a serious crossroads right now. Without an immediate response of continuing commitment to support LWRN (see John Kotmair's letter in this issue), we will not likely be around next month. Those who've been paying attention know that we must vacate our current offices, and before entering into any lease commitment at a new location, we must know that our membership is still willing and able to provide the necessary support. We hope and pray that you're in a position to help, because we still have a long way to go in educating the public for liberty, and we want Liberty Works Radio Network to continue to be a part of the process.
