Patriot Attorney sues IRS agents over illegal disclosures

Shreveport, LA — On December 26, 2007, Attorney Tommy Cryer filed a complaint in federal court against four IRS agents, alleging they waged a “smear and fear” campaign to destroy his good reputation and law practice.

All four IRS agents were part of a criminal investigation which ultimately led to an indictment against Cryer for felony tax evasion. Those charges were dropped and Cryer was tried last July on misdemeanor charges of failure to file federal income tax returns. On July 9, 2007, the IRS and DOJ were stunned when the jury rejected their misrepresentation of the federal tax laws by finding Cryer not guilty.

The jury verdict left the alleged IRS law-breakers wide open to be sued for damages related to the violation of federal privacy laws and for slander. Cryer contends that during the investigation, the agents — Jimmy Sandefur, Darrin Heusel, Jude Armand, and Patrick Potter — engaged in numerous illegal disclosures to Cryer’s clients. The four IRS employees violated federal laws forbidding the disclosure of tax return information, disclosures about an investigation and disclosure of grand jury proceedings. The suit contends that the agents discussed those issues in phone calls, letters and personal visits while interviewing Cryer’s clients during the investigation. The complaint documents 29 such disclosures, and Cryer reserves the right to supplement the complaint if additional disclosures are uncovered during discovery.

Cryer seeks at least \$1,000 in damages for each time an agent illegally disclosed information, in addition to punitive damages. He has also filed a criminal complaint against the agents with the U.S. Attorney’s Office.

Since 1973, Cryer contends, his law practice was built by word of mouth, hard work and honest dealing. The illegal disclosures cast him in a disreputable light and caused rumors that seriously impaired his ability to earn a living, resulting in the loss of many long-time clients. Cryer believes this outcome was the desired result and that the IRS agents sought to render him less finan-

sources, SAPF needs your help!!**

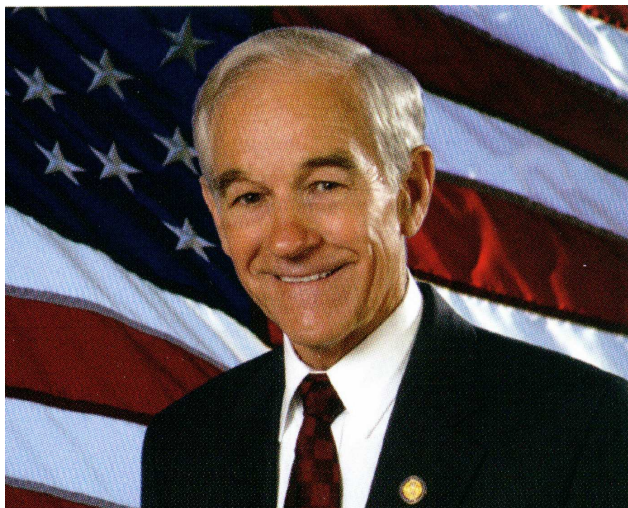
As you know by now, the Fourth Circuit failed in its duty to address the legal issues Save-A-Patriot Fellowship raised on appeal, and instead affirmed that it found “no reversible error” in the district court’s decision to enjoin the Fellowship. (See Liberty Tree, July 2007).

As the next step in this battle, SAPF filed a petition for a writ of certiorari on January 2nd to the Supreme Court. Nothing less than the survival of the First Amendment is at stake: will the Supreme Court reaffirm the First Amendment and uphold the right of SAPF to speak, publish, and sell opinions which disagree with the IRS and the courts, or has America sunk to the point where people can be thrown in jail for merely disagreeing with the government?

The cost of producing and submitting this petition was far more than expected, and could not have hit the Fellowship’s financial resources at a worse time. While we realize that some members have pledged monthly support for the Fellowship while we get Liberty Works Radio Network off the ground, we are asking that if you are not among those who have pledged, or if you can afford more than you pledged to help with the legal costs, please consider helping HQ in this time of need.

cially able to defend himself against criminal prosecution. The complaint states: "Given the clarity of the law and the obvious prohibitions of such needless disclosures, the conduct of Sandefur and his accomplices can only be regarded as knowing, willful, intentional and malicious."

SAPF note: We will keep you informed of future developments as they unfold. Let's pray for justice to prevail, and that this federal court reject the ongoing practice of protecting the wrongdoing of government employees.
