On November 27, 2007, as expected, the Fourth Circuit Court of Appeals ruled against the Fellowship's and my joint motion to stay the issuance of the mandate. They did not cite any legal reasoning in doing so. They merely stated: "Upon consideration of submissions relative to the motion to stay mandate, the Court denies the motion. Entered at the direction of delivered copper "Ron Paul" coins. A federal court clerk released the affidavit of probable cause before the court ordered it to be sealed. A review of the affidavit makes it clear why the federal judge wanted it sealed. It is hard evidence of a conspiracy to issue a bogus warrant for an illegal search, *since it contains no evidence that a crime had been committed!* This

The seditionist agents of the socialists in the federal government are desperate to try to shut down the Fellowship before we get the radio network up and running. It is now a foot race to reach Americans with the truth via that medium. The right to operate without keeping records for government

agencies was expressly recognized by the 1996 federal district court ruling in the Fellowship's suit against the government for return of property they seized in the raid on SAPF. Therefore, unlike other Patriot groups not having the benefit of such an order, they put the Fellowship injunction case on the fast track. They know full well the impact Liberty Works Radio Network will have on the American public, who are increasingly questioning the practices and policies of their governments.

In the meantime, the tyrannical plot to prevent exposure of the elites' seditious deeds is becoming even more widespread, quickly moving into all facets of lawful Patriot activity. On November 14, 2007, the FBI and Secret Service raided NORFED's offices in Evansville, Indiana, taking everything in sight including paper certificates, gold and silver coins, and just-

extreme effort to silence Patriotic dissent, shows how desperate they are becoming in regards

to the growing public awareness of their conspiracy to destroy our Constitutional Republic.

A Patriot lawyer examined the injunction order against the LWRN Fellowship application, and it was his opinion that this activity would not come under the broad and vague injunction order. As stated within the application, LWRNF members are totally separate from SAPF members in that they do not participate in the Member Assistance Program, nor are they eligible for casework or paralegal assistance.

Their only participation is their annual donation for the First Amendment operation of the radio network. There are no other requirements, eligibilities or obligations, which insulates them from any exposure of their identity to the seditionists.

I attended the Justice, Peace & Freedom Conference held on November 16th, 17th and 18th in Dallas, Texas, and presented the radio network plan. It was well received, with many pledges of involvement, and the LWRN DVDs sold like hotcakes. Several Patriot group leaders pledged to promote the drive for LWRNF members. All Patriot organizations participating will be afforded free airtime to promote their organization and particular Patriot cause. Finally the Patriot community has come together to work on this most important project.

WE HAVE THE PLAN!!

As soon as enough LWRN Fellowship members are recruited, WIFL, FM 104.3, in Ocala, Florida will be up-linked in stereo to a satellite. Then an inexpensive non-profit FM station, already located, will be purchased, and the stereo up-link will be split into two mono up-links. One mono signal will be for the commercial side (i.e., WIFL), and one mono signal will be for the non-profit side. Due to the fact that the Federal District Court in Baltimore has already declared SAPF to be a First Amendment unincorporated association, there will be no need for requesting that status of the IRS, whether otherwise required or not.

The programming is the same on both up-links, except for commercial breaks. Paid commercials will be broadcast over the WIFL up-link, while requests for donations will be broadcast over the non-profit FM stations.

The expectation for success of this plan is because of the ability to extend the non-profit FM station's reach with what are called "translators." Translators were authorized by the FCC for non-profit FM station use only. They are nothing more than a radio device that picks up the broadcast signal from the satellite and rebroadcasts it within its licensed broadcast area. A translator has its own call letters and frequency, and unless the listener knows otherwise, they would think it was a regular station, with studios and offices.

Because these translators are for non-profit use only, they are very inexpensive, comparatively speakAll Patriot organizations participating will be afforded free airtime to promote their organization and particular Patriot cause.

ing. Last year, for instance, 94.9 FM, Montville, Connecticut (Market: Hartford/New Britain, Connecticut) was up for sale at an asking price of \$25,000.00 for its license, and this is not an isolated offering. So, as you can see, with 100,000 members donating 99 FRNs (commonly called dollars) the Liberty Works Radio Network can spread the message of Liberty clear across these united States in no time at all.

In a presidential election year, with iscontent brewing in an ever more suspicious public, this goal is definitely achievable. Using the instructions accompanying the DVD, even if the goal of one hundred thousand members is not realized in three months, we will be well on our way to achieving it.





